Twelve Incubatees named Mr. Ajay Sharma, Mr, Anuj Sharma, Dr. Anil Singla, Mr. Bhanu Uday, Mr.Dilpreet Singh, Mr.Sairas Negi, Mr.Yatin Machaan, Mr.Girdhari Lal, Ms. Saras Gupta, Ms.Supriya Sharma, Mr.Jayendra Gupta and Mr.Abhishek Singh were invited for discussion with screening committee.
3. Among the Twelve incubatees, Six incubates named Mr. Anuj Sharma, Mr.Anil Singla and Mr. Bhanu Uday, Mr.Sairas Negi, Mr.Yatin Machaan, Ms. Saras Gupta, joined for the meeting.
4. The Proposal of Ms. Supriya Sharma was decided to be discussed in Next Screening Committee meeting as she was unable to join the meeting because of her medical reasons.
5. The five incubatees were advised for improvement in their proposal with the help of mentors available from JUIT. They were advised to re-submit their Proposals on the basis of recommendations, within fifteen days.
