

Proceedings of the 95th meeting of “Himachal Pradesh Micro & Small Enterprises Facilitation Council” held on 10.03.2026 at 03:00 PM in the “Conference Hall of Udyog Bhawan, Majitha House Chotta Shimla-02”.

The 95th meeting of “Himachal Pradesh Micro & Small Enterprises Facilitation Council” (herein after referred as HPMSEFC). reconstituted by the Government of Himachal Pradesh vide notification No. Ind. A-F010/13/2021 dated 07.08.2024 in accordance to provisions made under Section 20 of the Micro, Small & Medium Enterprises Development Act-2006 (hereinafter referred as MSMED Act), was held on 10.03.2026 under the Chairmanship of Dr. Yunus (IAS) Chairman, H.P. Micro & Small Enterprises Facilitation Council –Cum- Commissioner Industries, HP in the “Conference Hall of Udyog Bhawan, Majitha House Chotta Shimla-02”.

At the outset, the Chairman welcomed the members of the Council as well as other participants and apprised that Micro and Small Enterprises Facilitation Council (MSEFC) is to facilitate the resolution of disputes of micro and small enterprise (MSME) suppliers and their buyers, primarily ,concerning delayed payments for goods and services, as mandated by MSMED Act, 2006. As such, 183 no. of cases are taken up by the Council for conciliation and are detailed below:-

Item No. 1:-

In the following 03 cases, no representatives from both the parties i.e. supplier & buyer appeared for hearing before the Council, despite due notice and it is made clear that parties which are not turning up inspite of receiving the notices shall be considered as “wilfull absentees” and the Council shall take a serious view of the same and may consider to drop such cases. However, in furtherance to objective of the Act, the Council decided to give one more opportunity to the following references. These cases shall be heard in the next meeting. The parties are, hereby, cautioned that in next hearing if they failed to attend hearing, their references shall be dropped assuming that these suppliers are no more interested to pursue their case:-
