The successful tenderer shall have to depute Service Engineers for attending calls at respective locations in Himachal Pradesh, instantly; and shall also have to provide one centralized Telephone Number to register Service Calls. The successful tenderer shall also furnish performance security to the extent of five (5) percent of the total consideration amount of the contract. The terms and conditions for making the payment shall be regulated as per Rule 108 of the H.P.F.R., 2009.
