Keeping in view of above findings the Joint Technical Committee recommends that the bidders mentioned at S.No.1, 6, & 7 only have been found eligible for the sample inspection and other bidders at S.No. 5.No. 2,3,4,5 & 8 have not been found eligible on the basis of documents and hence not recommended/ found eligible for sample inspection and opening of the financial bids. The Committee further recommended that the sample inspection of the bidders who have been found eligible may be conducted at the earliest.
