**NOTIFICATION**

In partial modification to this Department's Notification of even number dated 23<sup>rd</sup> February, 2019, the Governor of Himachal Pradesh is pleased to amend Clause 3(viii), 5(a)(B) & 5(b) of the Scheme "Mukhya Mantri Swavlamban Yojna, 2019" as under:-

	<b>Amendment/Addition</b>
<b>Clause 3.(viii)</b>	"Industrial Unit" means any industrial unit where a manufacturing activity or a service activity for services as defined in Annexure-I of this Scheme is carried out. <b>Service enterprises and related goods carrier can be combined as composite related activities as per list of service enterprises given at annexure-1, but the overall ceiling be restricted as per scheme guidelines.</b>
<b>Clause 5(a)B</b>	<b>Extent of admissible subsidy:</b> All new industrial units would be eligible for: (a) Investment Subsidy @ 25% of investment as follows:- <b>A. <u>For Manufacturing Sector</u></b> investment in Plant & Machinery & technical civil works. <b>B. <u>For Service Sector:</u></b> The plant & machinery includes cost of construction of building and all other durable physical assets basic for running of that particular service industry but exclude cost of land and consumable, disposables or any other item charged to revenue: upto a maximum investment ceiling of <b>Rs. 60 lakh</b> in plant & machinery (or equipments) with

	<p>total project cost not exceeding <b>Rs. 100 lakh</b> (including Working Capital). In case such units are set up by Bonafide Himachali women entrepreneur(s) the maximum amount of subsidy admissible would be @ 30%. In case of proprietary firms/ Corporation/ Legal entities like Companies/ LLP's/ Partnership Firms wherein 100% equity is held by Eligible Bonafide Himachali and 100% shares are held by Women for availing Capital Investment Subsidy @ 30%. In case such units are set up by widows who are Bonafide Himachali and having age up to 45 years, the amount of eligible subsidy would be @ 35 percent.</p>
<b>Clause 5(b)</b>	<p>Interest Subsidy @ 5% for three years on loan upto <b>Rs. 60 lakh</b> sanctioned by a 'Financial Institution' as defined under these Rules, would be admissible to such eligible industrial units. The interest subsidy will not be admissible on defaulted/ rescheduled investments and the period of default shall be counted for determining the period of eligibility. The subsidy will be given directly to the banks.</p>


