





### **(Detailed Instructions for Notice Inviting Tender)**

1. Bid documents can be downloaded from the website <https://hptenders.gov.in> from 24.02.2026 at 05.00 P.M. onwards upto 11.30 A.M. on the date of opening of tenders.
2. The bids will be uploaded in electronic format on the website <https://hptenders.gov.in> from 24.02.2026 at 05.00 P.M. onwards upto 11.30 A.M. on the date of opening of tenders. The bids received will be opened on the dates mentioned against item(s) in the e-tender notice in the presence of the bidders. If the office happens to be closed on the date of opening of the bids as specified, the bid(s) will be opened on the next working day at the same time and venue.
3. A clarification session/ meeting will be held on 27.02.2026 at 11.00 AM to 2:00 P.M. in the office of Controller of Stores, H.P., Shimla-171002 to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in the "Instructions to Bidders" of the bidding documents.
4. **Instruction to Bidders regarding e-tendering process:-**
  - (a) To participate in bidding process, bidders have to get "Digital Signature Certificate" (Class-II or Class-III) as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. **Bidders, who already possess valid Digital Signature Certificates, need not procure new Digital Signature Certificates.**
  - (b) The bidders have to submit their bids online in electronic format with digital Signatures. No proposal/tender will be accepted on the basis of Hard copies/manual tender in physical form
  - (c) The department will not be responsible for delay in online submission for any reasons.
  - (d) Bidders should upload the scanned copies of documents for **cover** information as specified in the tender documents. The original document i.e. Affidavit of non-blacklisting of firm/company and additional documents if required, shall be submitted in favour of Additional Controller of Stores, H.P. before the date of opening of tenders.
  - (e) The tender documents shall be uploaded in two covers. Each cover shall contain separately the "**TECHNICAL BID**" and the "**FINANCIAL BID**".  
**Cover-1** shall be "TECHNICAL BID" containing scanned copies of uploaded documents as mentioned in the **Terms & Conditions of tender**. The "TECHNICAL BID" shall be opened on the date of opening of tender(s).

**Cover-2** shall be "FINANCIAL BID" containing BOQ (Bill of Quantity)" of rates. After the evaluation and approval of the technical proposal, the "FINANCIAL BID" of the technically qualified/accepted bids only shall be opened. Financial bids of the bidders who do not qualify the technical bids shall not be opened.

**(The financial bid need not be sent in hard copy format. This is only required to be uploaded online)**

- (f) The tender will be rejected, if any changes/tampering is found in the BOQ (Bill of Quantity).
5. Complete bidding process will be online.
  6. Tender/technical bid of concerned firm will be rejected at the time of opening of tender, if any bidder fails to upload requisite tender documents as per terms & conditions of tender.
  7. The Controller of Stores/Additional Controller of Stores may reject the tenders that are received with incomplete documents or non-receipt of requisite documents within stipulated period.
